TERMS AND CONDITIONS

FOR SIX2PAY AT AGRA SAFARI DEN & A.ROSENTHAL

1. Deposit Requirement:

To activate the Six2Pay process, clients must pay a non-refundable deposit of 20% of the total invoice amount.

2. Applicability:

The Six2Pay payment option is only available for Arms, Hunting Accessories, and selected camping and outdoor products above the retail price of N\$10 000.

3. Payment Period:

The Six2Pay payment option allows for a 6-month payment period, interest-free. Clients may choose to pay off the total amount over a shorter time frame, with the payment terms adjusted accordingly. The maximum payment period is 6 months.

4. Missed Payments and Cancellations:

If a client misses a monthly payment or cancels the transaction, any amount paid, excluding the 20% deposit fee, will be refunded to the customer.

5. Licensing for Firearms:

Clients purchasing firearms or rifles must settle the total invoice before qualifying to apply for a license.

6. Payment Responsibility:

Clients are responsible for ensuring that their monthly installments/payments are made to Agra Safari Den or A.Rosenthal as per the agreed schedule. Application forms for licenses and stock will be retained until the final payment is made.

7. Limitations on Six2Pay Payment Option:

Only one Six2Pay invoice per client is allowed. No additional items can be added to an existing Six2Pay transaction.

Documents Required:

- Certified copy of ID
- Bank account confirmation letter





FREQUENTLY ASKED QUESTIONS

FOR SIX2PAY AT AGRA SAFARI DEN & A.ROSENTHAL

1. What is the Six2Pay process?

Six2Pay is a financing payment option that allows you to pay for arms, hunting accessories, and selected camping and outdoor products in installments over a 6-month period or less.

2. How do I activate Six2Pay?

To activate Six2Pay, you must pay a non-refundable deposit of 20% of the total invoice amount.

3. What happens if I miss a payment?

If a payment is missed, the financing option may continue. However, if the total amount is not settled within the six-month timeframe, the Six2Pay agreement will be terminated. Any amount paid, excluding the 20% deposit fee, will be refunded to the customer.

4. Can I settle the balance owed on my Six2Pay at an earlier date?

Yes, you can pay off your financing plan over a shorter period if you prefer, with payment terms adjusted accordingly. The maximum payment period is 6 months.

5. When can I collect my product?

You can collect your product from the store once the total amount is fully paid.

6. Can I cancel my Six2Pay finance plan?

Yes, you can cancel your Six2Pay plan, however, any amount paid, excluding the 20% deposit fee, will be refunded to the customer.

7. What documents do I need for Six2Pay?

You will need to provide a certified copy of your ID and a bank account confirmation letter.

8. Can I add items to my existing Six2Pay financing plan?

No, only one Six2Pay invoice per client is allowed. Additional items cannot be added to an existing transaction.
